Senior Community Service Employment Program

Title V SCSEP

The Senior Community Service Employment Program (SCSEP) is a community service and work-based job training program for older Americans funded by the Department of Labor. Authorized by the Older Americans Act, the program provides training for low-income, unemployed seniors 55 years and older. Participants work an average of 20 hours a week and are paid the highest of federal, state or local minimum wage. This training serves as a bridge to unsubsidized employment opportunities for participants.

Program Eligibility Requirements

Call for an Eligibility Pre-Screening (989) 893-4506 or 1-800-858-1637

- **Age:** 55 years of age or older
- **Income:** within the Federal Poverty income guidelines
- **Unemployed**

Program Participation Requirements

- Active ongoing personal job search
- Participation in SCSEP In-Service Meetings
- Enrollment in Michigan Works Talent Bank

ENROLLMENT PROCESS

1. Verification of eligibility
2. Enrollment for services
3. Assessment of skills, experience, and employment interest
4. Development of individual plan for employment and training



Host Agency Employment and Training Assignment

A host agency is a nonprofit organization that has an agreement with Region VII Area Agency on Aging to provide employment and training to assigned enrollees.

- Assignment compatible with desired employment and training
- Day to day supervision provided
- Paid work and benefits through SCSEP
